DEPARTMENT OF VETERAN AFFAIRS

The Department of Veterans Affairs/Greater Los Angeles Healthcare System holds quarterly "stakeholder" meetings in which the community is invited to hear about construction updates and clinical programs at the VA. If you are interested in attending one of these meetings, please contact us through the SBRA web site.

The most recent meeting was held on January 20, which coincided with the release of the Veterans Programs Enhancement Act-driven Draft Master Plan for the campus. The bulk of the meeting was spent going over the draft plan. (A complete copy of the 39-page document is available at:

It summarizes the work of previous planning studies to address future development of the land while supporting patientcentered care, research, and education. There are certain legislative restrictions to be considered as well, such as a prohibition against commercial development or disposal of the land. Finally, historic preservation and environmental concerns are added to the mix. The plan calls for the construction of an inpatient tower, a nursing home, a research facility, homeless therapeutic housing, and possibly a columbarium on the north side of the campus. The document also reaffirms the VA's contract with the Veterans Park Conservancy, a nonprofit organization, for building a Veterans Memorial Park at Wilshire and San Vicente.

SBRA TRANSPORTATION UPDATE

February, 2011 By Lauren Cole SBRA has been tracking some important transportation projects impacting South Brentwood. Here is an update on some key projects:

BUNDY VILLAGE

This massive development proposed for the area near Bundy and Olympic is currently on hold. Your calls and emails to Councilmen Rosendahl and Koretz definitely made a difference. The developer is currently in bankruptcy, and potential lenders are aware of the strong community opposition to the project's current size, which is much too big for the gridlocked area. The developer has stated that he is not giving up on Bundy Village, and says he plans to come up with a revised project plan. Despite repeated requests, he has consistently refused to meet with community members to discuss his revised plans. Stay tuned for further updates.

WILSHIRE BUS RAPID TRANSIT

This proposal to take out two lanes of traffic to establish dedicated bus lanes on Wilshire Blvd. during morning and evening peak hours is currently under review by the County and the City Council. Brentwood residents may recall that trial bus lanes were instituted in 2006 and the impact on traffic on streets like Sunset, San Vicente, Montana, and Wilshire was so severe that the trials had to be terminated early. While encouraging people to take mass transit is a worthy goal, to date Metro has not provided an analysis that compares the benefits for

current and potential bus riders to the potentially severe time delays for drivers, many of whom do not have the option to switch to the Wilshire bus. Councilman Rosendahl introduced a motion which was passed by the City Council directing Metro to study a contiguous bus lane that starts at La Cienega and ends at Park View near MacArthur Park, which is currently the easternmost point of the proposed route. The cities of Beverly Hills and Santa Monica are not participating in the bus lane project, and large sections of Westwood have been eliminated from the route. Given that the section from Centinela to the 405 would not even be connected to the rest of this fragmented project, it is likely that removing this section may not have any material impact on bus speeds for the overall project, or at least not enough to justify the extremely negative impact on traffic that may result. SBRA supports Councilman Rosendahl's efforts to ask Metro to provide the data so that local residents and commuters can make an informed decision about whether or not bus lanes in our area make sense.

WILSHIRE SUBWAY

A final environmental impact report (EIR) for the subway is being prepared and should be released by this summer. The EIR's study area is from Western Avenue (currently the easternmost stop on the subway) to 4th Street in Santa Monica, and would include a stop at Bundy and Wilshire. Current funding for the project only covers as far as the VA Hospital, so getting further west including to Bundy will require additional funding in the future. Mayor Villaraigosa is lobbying Congress to get "30/10 funding", which would reduce the current timeline of having a stop at the VA in 30 years to 10 years. SBRA supports the subway, and is voicing its opinion on issues such as requests that parking be provided near the stations so that subway users won't have to drive around residential areas looking for parking. Whether or not the VA stop will have accessible parking is still under discussion, and clearly failing to provide parking will make it difficult for Brentwood residents to access the station, which is likely to be near the VA Hospital south of Wilshire. GOODBYE TO OFFICER DENNIS HINMAN

Brentwood will soon bid farewell to long-time residents, Dennis and Peggy Hinman, who have purchased a home in Silverlake. The news was met with disappointment as the Hinmans are well known and genuinely loved in the community, having raised their family here in South Brentwood.

Dennis is a native of Los Angeles and graduated from Hollywood High School. He joined the Marine Corps in 1968, spent a year in Vietnam, and attended San Diego State University, graduating with a degree in Recreation Administration. After a stint as Director of the Boys Club of Escondido, Dennis signed on "to protect and serve" with the Los Angeles Police Department in 1975– a career that eventually spanned thirty-one years.

In the early morning hours of January, 1992, Dennis and his partner responded to a robbery in progress at a Northridge restaurant. Two armed robbers took a hostage during the confrontation. Dennis was shot on his hip, and the bullet went into the police radio in his back pocket. Bleeding and in severe pain, he kept his cool and shouted to the nonexistent backup, "Stay back! I'll talk to them!") The hostage was released and the gunmen surrendered. Dennis's signature traits -- quick thinking and fast talking served him well. For his heroism, Dennis was awarded the Medal of Valor, LAPD's highest honor.

Later, Dennis spent eight years as Brentwood's Senior Lead Officer. In that role, he became well acquainted with just about everyone -- from Brentwood's movers and shakers to the homeless encamped in alleys. He was very effective. Folks were drawn to him because of his likeable manner and quick wit.

After he retired in 2006, Dennis assumed a variety of leadership positions in the community including President of the Rotary Club, Representative on the Brentwood Community Council, a Director of the South Brentwood Residents Association, and a member of the Knights of Columbus at St. Martin of Tours Parish. Dennis enjoys taking long walks through South Brentwood, keeping an eye on things while schmoozing with neighbors. We will all miss his cheerful greeting.

The Hinmans promise to return to Brentwood for church functions and special events. We're counting on it!
