Dear Norman:

Thank you so much for your leadership in working to resolve the Bundy/Mayfield stop sign problem. SBRA conducted a survey which asked if residents wanted to remove or keep the new stop signs at Bundy and Mayfield. (Text of our survey is below.)

The results were:

Remove	120	83%
Keep	25	17%
Total	145	

Those who participated in the survey objected to the stop signs and resulting traffic and safety problems they have created. We made it clear in the survey that if the stop signs were taken out that no additional mitigations would be installed.

But there still are speeding and safety issues on Bundy. We understand that DOT has no funding at the moment for any additional mitigations, but we hope that DOT will consider methods of speed control such as radar speed control signs in future discussions when funds are available.

Remove or Keep the New Stop Signs on Bundy?

Recently, the Los Angeles Department of Transportation (LADOT) erected new stop signs on Bundy Drive, making the intersection of Bundy Drive and Mayfield Avenue a four-way stop.

Now, because of community feedback our Los Angeles City Councilman Bill Rosendahl is concerned that the new stop signs are creating more safety hazards, not less. For example, the resultant back up, often as far as Wilshire Blvd., has the unintended consequence of drivers cutting through side streets, which are not equipped to handle the traffic.

Now, LADOT and Councilman Rosendahl are asking us to ask you:

DO YOU WANT THE CITY TO REMOVE THE NEW STOP SIGNS ON BUNDY AT MAYFIELD?

Yes Remove Them! or **No Keep Them!**

Representatives of the Brentwood Community Council, the South Brentwood Residents Association and the Brentwood Homeowners Association met with the Council office and LADOT to discuss the situation after a survey disclosed widespread dissatisfaction with the new stop signs. It was the result of those surveys that has convinced the Council office and LADOT to consider removing the signs. This email is being sent in response to a request from Councilman Rosendahl's office.

Please note: If the stop signs are removed the intersection will be restored to the way it was and no other alternative measure will be put into place.
