**ROBBERY: 0**

**ASSAULT: 1**

Barrington/Wilshire Blvd

On 10/31/16, at 0130, Suspects (two Male, Hispanics, no further description), approached the victim and struck the victim in the back of the head with a bottle.

**BURGLARY: 7**

11600 Montana Ave

On 10/26/16 at 0055, suspects (Male and Female White in their 20's) gained entry to apartment complex and used a tool to open mailboxes. **Both suspects in custody and arrested for burglary.**

Westgate/Kiowa

Between 11/08/16 and 11/10/16 a bike rack was stolen from the back of victim's vehicle.

1100 Granville

On 11/09/16 between 1600 and 1620, victim left stroller with wallet in it in the lobby to let the child play out front. When victim returned, the wallet was gone.

11900 Kiowa

On 11/10/16 between 0100 and 0700, unk suspect(s) entered parking garage and stole rims and tires valued at \$5,000.

11900 San Vicente (commercial)

On 11/10/16 at 1430, suspect (Male, White, 30 years old) entered business and removed property. Suspect fled on foot.

11600 San Vicente (commercial)

On 11/10/16, at 1615, the suspects (Male and Female Black, late 50's to early 60's) entered the store to look for rings. Suspect 1 reached over counter and removed a diamond ring valued at \$24,000.00

333 S. Barrington Ave

On 11/10/16 at 2100, the victim had placed his cellphone on a bench while playing basketball. The suspect (Male, Black, 160 lbs, early 20's) removed the cellphone valued at \$902.00

11900 Kiowa

Between 11/10/16 and 11/11/16, unk suspect(s) entered parking garage and stole rims and tires valued at \$2,000.

**Note:**

There are an ever increasing number of audacious ways thieves come up with to get you to part with your money. It's hard to keep up with all the new methods and techniques to defraud people, particularly the elderly and foreigners. But before you believe that it could never happen to you, keep in mind that the methods are getting increasingly sophisticated as time passes and it's sometimes very hard to tell what is legitimate and what is a scam. I recommend that *everyone* sign up with the Federal Trade Commission's scam alerts at **[ftc.gov/subscribe](https://www.ftc.gov/subscribe)**.

Here's a relatively newer one that will be particularly convincing now that the elections are over. They are 'Health Care Scams' and here's how they work (**this comes straight from the FTC**):

You see an ad on TV, telling you about a new law that requires you to get a new health care card. Maybe you get a call offering you big discounts on health insurance. Or maybe someone says they're from the government, and she needs your Medicare number to issue you a new card.

Scammers follow the headlines. When it's Medicare open season, or when health care is in the news, they go to work with a new script. Their goal? To get your Social Security number, financial information, or insurance number.

So take a minute to think before you talk: Do you really have to get a new health care card? Is that discounted insurance a good deal? Is that "government official" really from the government? The answer to all three is almost always: No.

Here's what you can do:

- 1) Stop. Check it out. Before you share your information, call Medicare (1-800-MEDICARE), do some research, and check with someone you trust.
- 2) Pass this information on to a friend. You probably saw through the requests. But chances are you know someone who could use a friendly reminder.
- 3) If you spot a health care scam, please report it to the Federal Trade Commission by calling the **FTC at 1-877-FTC-HELP** or TTY1-866-653-4261 or you can go online at **[ftc.gov/complaint](https://www.ftc.gov/complaint)**
